## PRESENTATION BIOGRAPHIES AND SESSION DESCRIPTIONS

# Anjli Acharya



#### **PRESENTER BIOGRAPHY**

Mrs. Acharya is a pharmacist and independent clinician specializing in immunizations and travel health at the **Bowmont Medical and Travel Clinic in** Calgary, Alberta. As past-president of the Alberta College of Pharmacy and the **Canadian National Association of Pharmacy** Regulatory Authorities (NAPRA), Mrs. Acharya has been engaged in provincial and national discussions on pharmacist's role in the delivery of public health and travel health services. Mrs. Acharya has over a decade of patient care experience in the delivery of immunization and travel health education and is a member of the International Society of Travel Medicine. Mrs. Acharya is currently a member of the Committee to Advise on Tropical Medicine and Travel (CATMAT) with Public Health Canada.

#### **PRESENTATION DESCRIPTION**

Individuals aged 65 years experience a higher risk of the negative outcomes from influenza infection. This program will support pharmacy technicians with the knowledge to discuss influenza vaccine and support immunization decisions for adults aged ≥65 years old. The program will review the influenza burden in this population, the types of adverse outcomes experienced by older adults, and annual National Advisory Committee on Immunization (NACI) Influenza guidelines. The presentation will also discuss the benefits and challenges in addressing patient and caregiver concerns around vaccine selection and vaccine hesitancy.

#### **LEARNING OBJECTIVES**

- 1. Recognize the importance of influenza vaccination in adults over the age of 65 for limiting the medical and functional impact of influenza in this population.
- 2. Describe the burden of influenza disease beyond the respiratory system and the concept of immunosenescence.
- 3. Review seasonal flu vaccines available for adults aged 65 and older based on the National Advisory Committee on Immunization (NACI) Statement for 2022-2023, including a brief pneumococcal vaccine update.
- 4. Address patients' and caregivers' concerns around vaccine selection and hesitancy to immunize.



#### **PRESENTER BIOGRAPHY**

Helen graduated from the University of Alberta in 2016 and then from the University of Alberta PharmD program in 2019. She's been a clinical pharmacist with Calgary Co-Op since 2018 and got her Certified Diabetes Educator certification in 2020, received her Certified Tobacco Educator in 2021, and her Certified Bariatric Educator in 2022. She's had the opportunity to manage many chronic conditions including Diabetes in a variety of settings including the Edmonton Remand Center, Alberta Hospital, Transplants Unit and psychiatric unit at the Foothill Hospital, and Emergency at Sturgeon Community Hospital. She has also gotten additional



training at C-endo, an endocrinology clinic in Calgary in both community diabetes management as well as pump therapy. She continues to be a big advocate for accessible and improved community care as well as advancing pharmacy practice. She also continues to invest and support technicians fully utilizing their scope.

#### **PRESENTATION DESCRIPTION**

This presentation will allow attendees to gain an understanding of the different types of diabetes testing supplies available in the market, including capillary

blood glucose monitors and continuous glucose monitors. Attendees will learn about the differences between each type of testing supply, how to operate each type of testing supply, and the distinguishing features of each product. The presentation aims to equip attendees with the knowledge and skills necessary to effectively help patients with diabetes manage their condition and choose the best testing supplies for any particular patient's needs.

#### LEARNING OBJECTIVES

1. Understand the basic principles of diabetes testing, including how capillary blood glucose and continuous glucose monitors differ, and be able to explain these principles to patients.

2. Demonstrate proficiency in using / attaching different types of diabetes testing supplies, including capillary blood glucose meters and continuous glucose monitors.

3. Recognize and differentiate the distinguishing features of various diabetes testing supplies, including One Touch, Contour, Freestyle, Libre, and Dexcom, to help patients make informed decisions about their diabetes management needs.

#### **PRESENTER BIOGRAPHY**

#### **PRESENTER BIOGRAPHY**

Melanie Dorey is a registered pharmacy technician and has worked in the compounding industry for over 17 years. She graduated from La Cite Collegiale's 2-year Pharmacy Technician program in 2006 and at the Children's Hospital of Eastern Ontario (CHEO) where she acquired a passion for sterile and nonsterile compounding. While attending the Sterile Compounding Boot Camp in Denver, Colorado in 2007, Melanie met several key industry experts who ignited her passion for sterile and nonsterile compounding. In 2014, she joined the team at CriticalPoint and Kastango Consulting Group where she continued to hone her skills while developing eLearning, standard operating procedures, as well as in person and virtual lectures. She also traveled to client locations to perform competency



assessment and customized training. Melanie has served on a variety of committees with NAPRA and the Ontario College of Pharmacy. She now owns Critical Compounding Resources which offer training and consulting services in both Canada and the US.

#### PRESENTATION DESCRIPTION

Policies and Procedures (PnPs) must be developed and regularly reviewed for pharmacy operations. Pharmacy Technicians play a vital role in all elements of the

pharmacy's operation which makes them better suited to develop and review policy and procedures. The development process can be daunting, but this presentation walks through the important policy and procedure elements and how to develop them to improve personnel compliance.

## Terresa Hennessey



#### **PRESENTER BIOGRAPHY**

Since receiving her pharmacy technician diploma in 1998, Teresa has practiced in front-line and leadership roles in both community and hospital pharmacies. Her leadership career has been a combination of practice leadership and operations management. She is a certified change practitioner and process improvement green belt. Teresa is currently employed with Alberta Health Services, Pharmacy Services as Senior Advisor, Equipment Strategy & Coordination. In this role, Teresa uses her experiences from both personally using pharmacy equipment and managing automation of the distribution system, to provide strategic oversight of Alberta's hospital pharmacy equipment.

#### **PRESENTATION DESCRIPTION**

Medical devices range from simple products such as adhesive bandages and toothbrushes to more complex products such as x-ray machines and pacemakers. The use of medical devices and other equipment and technologies in pharmacy practice is not new but is a growing trend as pharmacy teams look for ways to improve quality, accuracy, and efficiency. As a pharmacy professional, it is important to be aware of the types of medical devices and how to ensure the safety of your patients as well as yourself and your team when working with equipment.

#### **LEARNING OBJECTIVES**

At the end of this session, participants will be able to:

1. Identify medical devices commonly encountered in pharmacy practice and understand related regulatory requirements

2. Apply medical device risk classification to the use of pharmacy equipment

3. Describe how quality control and quality assurance relates to the use of pharmacy equipment and devices

# Kathy Hayward

#### **PRESENTER BIOGRAPHY**

Kathy Hayward is a pharmacist, Certified **Respiratory Educator and Certified Tobacco** Educator who has worked in Community pharmacies, Outpatient clinics with specialists and in Primary Care multidisciplinary teams while working with the Alberta Health Services, Calgary COPD & Asthma Program. She is currently at the Calgary Co-Op Pharmacy Specialty Hub. She graduated from the University of Saskatchewan, and worked in Alberta in several communities. She finds that being an educator allows her to collaborate with other health care professionals and encourage dialogue with people seeking care in pharmacy. Within the Outpatient Specialty clinic setting, she has been able



to use a number of her skills in helping people achieve better outcomes with treatment of Asthma and COPD. She had the privilege of being a co-author on the CTS Statement Update on Mild and Very Mild Asthma 2021, and has authored articles for pharmacy publications and CE's. She finds helping other professionals increase their knowledge and skills to help people manage their health conditions. Pharmacists and Licensed Pharmacy Technicians are perfectly positioned to build relationships with people who are being treated for these conditions and greatly improve how their medications help their respiratory condition.

#### **PRESENTATION DESCRIPTION**

Over the last 5 years, many changes have occurred in medication and devices available for respiratory conditions such as Asthma and COPD. These new medications offer many opportunities to improve outcomes for the people that technicians will see. There have also been many new guidelines with major changes in when to step up therapy for COPD to prevent serious consequences for patients and the health care system. This talk with focus on the role of technicians in helping with patients who are needing a change in therapy, observing inhaler technique and suggesting changes to prescribers. Poor inhaler technique can result in getting no medication at all, a critical error. Knowledge of when to change therapy can have significant improvements in quality of life and prevention of flare ups. Familiarity with the most up to date guidelines for COPD and Asthma, both Canadian and international, will provide the recommendations for changes.

#### **LEARNING OBJECTIVES**

1. Be able to question patients about the use of their inhalers and the benefit they are getting

2. Be able to communicate decreased effect or overuse to patients and pharmacists to assist in change in therapy

3. Be able to provide references and placebo devices to improve use of inhalers, such as print, video or demonstrations

4. Be able to find and store virtual resources for use in practice setting to encourage best treatment dependent on patient issues and new treatments

5. Be aware of and able to describe non pharmacologic resources sold in pharmacy and for patient use at home, such as video, internet or community programs

# Melissa Myrach



#### PRESENTER BIOGRAPHY

Melissa leads a skilled team of assistants, technicians and pharmacists focused on engaging with care partners, patients and caregivers as the manager of a pharmacy fulfillment centre servicing group homes, supportive living and long term care homes all across Southern Alberta. She started her career in pharmacy 23 years ago after first graduating with a Business Management Degree and then taking on administrative and data entry tasks at a small rural pharmacy in Manitoba which turned into the first internet pharmacy shortly thereafter; employing over 200 pharmacy workers. As a pharmacy technician, she has been enhancing her

leadership skills and serving as Operations Manager for several LTC pharmacies over the past 17 years while living in Alberta. She has implemented educational programs for nursing staff on medication administration as well as various eMAR training programs. #### **PRESENTATION DESCRIPTION**

The main purpose of this presentation is to excite the audience and get them thinking

"beyond the box" of the traditional pharmacy technician role and realize that there are many other great opportunities available; beyond the traditional role; whether it be as an educator, researcher, automation and technology specialist, a quality assurance lead or a leadership or management role.

The presentation has the background of colourful fireworks and the spectrum of the many colours of those fireworks move into the many roles available for technicians to fit into. It explores these non traditional career paths and gets the audience thinking about their why, their current skill set and what they may need to do to proceed into a new career pathway in the pharmacy technician profession; or how to create a new niche or enhance their role within their current setting.

#### **PRESENTATION DESCRIPTION**

The art of children's compounding

I will discuss and touch on a few key areas:

1. Drug compliance with kids (encompass dosage forms and creating custom flavours)

2. Flavouring (tasting and tweaking using bitter stop salt or sugars)

3. Creating compounds for shorted medications or unavailable meds

4. pH testing and importance of a proper formula

#### **LEARNING OBJECTIVES**

1. Flavours:

Understanding patient needs and wants. What is the child's favourite flavours, creating a flavour tasting bar for them to choose what they like. Being able to change flavour from fill to fill (which is anywhere from 14-30 days)

2. Dosage Form:

To create better medication compliance in children using a preferred dosage form (liquid, gummies, or chocolates). Being able to adapt and change forms from fill to fill (usually 30 days)

#### 3. Adaptability:

Being able to have shorted or discontinued medications available for children the same day they are requested. Such as acetaminophen, ibuprofen, sulfamethoxazole trimethoprim, or amoxicillin. Listening to the community on the needs that should be met for their children.
